Summary

Dr Oldmeadow is the Associate Director (Data Sciences) at the Hunter Medical Research Institute (HMRI), NSW Australia. He is an applied statistician with an international reputation for managing, maintaining, and analysing large complex health-related data sets. He oversees statistical consultancy projects from various fields of research, including Cancer, Stroke, Cardiology, Respiratory, Public Health, and Health Services. He has a strong track-record in co-ordinating the analytic plans of research projects. He has 15 years of experience as the statistical leader for the design, analysis and data management of clinical studies, ranging from Pilot/Phase1 through to Phase 4, and across the spectrum of translational research.

Dr Oldmeadow's methodological expertise spans a broad range of experimental settings, such as single arm trials, parallel group, cross-over, stepped-wedge; biomarker and diagnostic studies; as well as observational studies, registries and linked administrative data sets. He is also actively researching statistical methodologies in biostatistics in the areas of causal modelling, missing data, and Bayesian statistics.

Dr Oldmeadow has received over \$20M in competitive funding, he has over 340 journal publications, with over 12,000 citations, a h-index of 45, and an i10 index of 147.

Impact

Development of new statistical methods

Oldmeadow's PhD research constituted the application and development of statistical methods in bioinformatics and biostatistics; specifically, the development of a generalisation to the Bayesian segmentation and classification model. Oldmeadow's strong skills in statistical methods development have resulted in novel research methods for analysing complex data. Oldmeadow also actively researches statistical methodologies in biostatistics and genetic epidemiology.

WHO Tobacco Free Initiative

Oldmeadow's two co-authored reports have contributed to important public health initiatives and partnerships. Oldmeadow's contribution to the commissioned report for the World Health Organization (WHO) provided important evidence on the prevalence of smoking-proxy electronic inhaling systems use in youth. This research informed the WHO report to the Conference of the Parties to the WHO Framework Convention on Tobacco Control on Electronic Nicotine Delivery Systems and Electronic Non-Nicotine Delivery Systems. It provided regulatory options for parties to prevent the initiation of electronic nicotine delivery systems and electronic non-nicotine delivery systems by non-smokers and youth, and with special attention to vulnerable groups. Overall, this has contributed to the WHO Tobacco Free Initiative's mission to reduce the global burden of disease and death caused by tobacco.

Chronic Care Service Enhancement Program

Oldmeadow contributed to program evaluation report for the NSW Department of Health, provided important statistical analysis and evaluation of the 'Chronic Care Service Enhancements Program', which aimed to reduce the burden of chronic disease amongst NSW Aboriginal people by partnering with Aboriginal Community Controlled Health Services (ACCHSs) in developing and implementing strategies to improve chronic disease screening and management. The analysis found the implementation strategies were associated with a statistically significant increase in the proportion of patients being screened for diabetes, but no significant change in other areas for example, Aboriginal Health Assessments, completion of minimum annual cycles of care for patients with diabetes and completion of General Practitioner (GP) Management Plans for patients with diabetes. These findings led to valuable recommendations within the report including the enhancement of efforts to increase annual health checks.


Contribution to policy documents

Oldmeadow has had five publications referenced in policy documents. Oldmeadow's journal article 'A case for not adjusting birthweight customised standards for ethnicity' provided evidence on the characteristics and health behaviours during pregnancy that affect birthweight. This research was cited in a policy paper titled 'Nutrition Justice: uncovering invisible pathways to malnutrition'. This policy paper described a way forward to meet the Global Health goal of nutritional sufficiency for all. Oldmeadow's papers around understanding and improving smoking cessation for Aboriginal Women during pregnancy have been cited in a review titled 'Review of tobacco use among Aboriginal and Torres Strait Islander peoples'. This review synthesised evidence on smoking, ways to help smoking cessation and providing comments for future directions and opportunities to address tobacco use. In addition, Oldmeadow's paper titled 'Improving smoking cessation care in pregnancy at Aboriginal Medical Services' was cited in a commissioned report by Public Health England that examined policy and regulations for e-cigarettes. Oldmeadow's paper titled 'Gene discovery and polygenic prediction from a genome-wide association study of educational attainment' was cited in a report by the United Nations

Development Programme (Human Development Report 2019). This report focused on major development issues, trends and policies and aim toward reducing global inequalities.

Dr Oldmeadow has averaged over 50 publications per year for the last 7 years and his papers have reached 12000 citations
